

Dear Parents,

Hope our students and you have had a safe and happy Puja!

As you are aware, we have made consistent and untiring efforts to reach out and continue the task of disseminating education even in these very troubled times.

In the light of the pandemic and keeping with the order dated 13th October 2020 passed by the Hon'ble High Court of Calcutta, we have reviewed the Fee Structure for the current academic session.

In the case of parents who have paid more than the present calculation, the 'excess' fee will be adjusted by the end of this academic session. Fees, if any, payable in terms of this order for the period up to November 30, 2020 need to be tendered by November 30, 2020.

You are aware that The Future Foundation School follows a progressive pedagogy that caters to the holistic development of the child. Our multi- pronged activities are designed keeping this in mind. The Fee Structure of the school has, over the years, reflected that reality. Even in a virtual environment, that remains our approach.

While we understand there may be some or many amongst you who are facing serious issues in the prevailing situation, you will nevertheless appreciate that the school and its efforts will be greatly impacted by this fee reduction and in that light, we put forward the remarks of the Hon'ble High Court of Calcutta, which requests parents and guardians not to avail of the reduction in fees if their financial situation does not merit the reduction {Para 61 (vii)}. We will appreciate if some of you choose not to seek adjustment of 'excess' fees paid. In that case, a mail to the school id to that effect be sent (mentioning name of the child, Unique Id, Class & section). However, you may decide to avail of the adjustment facility.

In both cases you are kindly requested to tick the relevant box in the online Fee portal, indicating your choice. You will be notified in due course about the opening of the online Fee portal.

Please note the reduced fee structure, in terms of the judgment and order dated October 13, 2020 of the Hon'ble High Court of Calcutta, is under appeal in the Hon'ble Supreme Court, and subject to the outcome therein.
